5. Please outline the project/program and funding you pitched for at the TFN event.

Our pitch focused on establishing a Day Program to provide the existing Vocational Training to additional participants (all living with a disability), in the local community. We would need to purchase a 10 seater van as a means of transporting the participants to the Centre for training, and to purchase additional resources (Sewing and knitting machines) to accommodate the extra participants.

#### Impact of Funding

6. Please describe how the funding was used and the implementation of the project/program.

In November 2021, with the news that our children could return to the Centre post COVID lockdown, the funding was put to use immediately with the purchase of a 10 seater Van. This enabled us to reach more youth in the community and offer them the opportunity to attend our Vocational Training. Hellen liaised closely with the local Masaka City Disability Officer to better learn who would benefit most from the opportunity.

A large function marquee was purchased to provide additional space for the extra students and resources.

The following equipment/resources were purchased

- 8 x Sewing Machines
- 2 x Knitting machines
- 4 x Tables
- 10 x Chairs
- Materials and resources to allow the students access to gain practical experience.
- Employment of a staff member to cook a lunchtime meal for the students so their time was fully utilised in the training program.

With all this in place, in late November the Day Program officially begun with 13 youth attending 4 x days a week. We also secured school enrolments and apprenticeships for those children who had the ability and desire to pursue these opportunities.

In April 2022, our remaining funds were used to purchase 4 acres of land close to the Smiling Hearts Centre, this enables us to grow our own food and raise some animals for sustainability. Timing is perfect as we were really noticing the rise in food expenses related to increased numbers of kids now attending the Centre and the significant cost of living in Uganda post Covid (Some products 3 times what they once were).

Hellen and the kids have been working tirelessly to clear the land and plant crops of Sweet Potatoes, Maize, Cassava and Matooke. To become as self sustaining as possible, we have many plans and look forward to making them a reality in time.

7. Please describe the impact that the TFN funding has had on your organisation.

The impact of the TFN funding has been pivotal for our growth and success as an Organisation. We have been able to fast track and implement our dreams and goals to improve the lives of young ones living with a disability. Having the funds to target into education and training opportunities has freed our personal funds to direct into the Outreach Program were we assist children with medical interventions to overcome or assist their disability and provide their carers with an opportunity to generate an income through a home based initiative enabling them to care for their children at home.

As well as a means of transportation for the new day students, the vehicle has strengthened social connections for the Smiling Hearts in rural locations. More recently, the Smiling Hearts have been able to go out to the farm daily to work the land. This would not have been possible without the van or the purchase of the land. And again, we will be more financial secure as the land will reduce our ongoing monthly costs to provide food for the participants.

## 8. How many people have been supported by programs or activities that were funded by the TFN donations?

The Program that has been implemented on the back of the TFN Funding opportunity has had an indirect impact on the entire disabled community, but on a granular level its had a direct impact on the below:

- 13 x Day Scholars attending the Day Program four times a week
- 2 x Apprenticeship students
- 21 x Boarders at the Centre
- 13 x Children in the Outreach Program
- 8 x Carer home based initiatives
- 8 x Students living independently

The Funding Network event has allowed us to support 38% more people than the same time last year.

e.g. 45 young people participated this year, which is 25% more than last year, thanks to the new Volunteer Coordinator resourcing.

- 2 x Pedal Sewing Machines = \$230 AUD
- 2 x Knitting Machines = \$565 AUD
- 4 x Tables = \$150 AUD
- 10 x Chairs = \$265 AUD
- 1 x Permanent Marquee structure = \$1050 AUD
- 1 x 10 Seater Bus = \$26,800 AUD

Materials & Sewing Needs = \$312 AUD

New Overlocking machines for tailoring = \$2460.36 AUD

4 x Acres of land = \$27,820 AUD

TOTAL = \$60,612.36 AUD

## 12. Describe if, and why, any of the funding was used differently from what you described in your original pitch/budget..

Our pitch was for \$30,00 and this was used and implemented as pitched.

The excess funds (\$26,785 AUD) have been used to purchase 4 acres of land to aid self sustainability through growing crops and raising animals.

#### 13. What measures did you use to assess the impact?

No formal data was collected, however the impact was deemed successful due to:

- Increased numbers of youth with disabilities receiving skills/ competence in sewing, knitting, bakery & printing
- Increased numbers now receiving academic education
- An increase in orders for goods made by the Smiling Hearts at the Centre, allowing them funds to assist some in becoming self sufficient and increasing their sense of worth
- An increase in referrals from the Regional Disability officer, self referrals and other NGO's wishing to enrol participants.
- Due to the credibility and success of the program, Hellen (Co- Founder) was invited to be a representative of the Masaka Disability Council, as advocate in the empowerment of people with disabilities.
- Food grown on the 4 acres is now reducing the monthly costs of feeding for the children

# 14. Describe three ways that your organisation has changed in the past 12 months since the event. (You can also describe here how Covid-19 restrictions have impacted on and changed the way you work).

Due to the funds received at the TFN Live event, we have grown in size by 38% and have gained more credibility amongst the Ugandan community. This is evident from the increased referrals to the Program from Council Disability Services and other respected NGO's.

Hellen our Co - Founder has grown in confidence and is now a respected member of Masaka Rotary and represents those with disabilities on the Disability Council of Masaka. She feels more confident to seek and apply for funding grants in the country when relevant and available.

Since COVID, we have not been able to visit Uganda to bring crafts back to Australia to sell. However, the Smiling Hearts Centre have obtained local marketing of their goods. This is resulting in an ongoing small income earned in the Country. This will relieve some burden of sourcing markets and selling the goods in Australia.

Although the land is only in the early stages of establishment, the reduction in food costs will be a great relief financially for the program. The last 6 months have brought increases in food and living costs. Our monthly income has not been covering our costs, so this will be an enormous asset.
